

## Poundland Limited Terms & Conditions

1. These terms and conditions are the terms and conditions that apply to the Golden Ticket Competition (the "Competition") as promoted by Poundland Limited (company number 02495645) whose registered office is at Wellmans Road, Willenhall, West Midlands WV13 2QT (the "Promoter"), unless otherwise expressly stated. 2. Participation in the Competition constitutes acceptance of these terms and conditions, which include the instructions for entry, details of the prizes and other information in relation to the Competition. In the event of any dispute regarding the conduct of the Competition and all matters relating to the Competition, the decision of the Promoter will be final and binding and no correspondence or discussion shall be entered into. 3. The Competition comprises of 13 golden tickets (the "Ticket(s)") being placed in randomly selected variety packs of the following Weight Watchers crisps: (i) 5 packet variety pack containing: Cheese Puffs, Salt and Vinegar Hoops, Nacho Cheese Tortillas and Hot Chilli Tortillas; or (ii) 6 packet variety pack containing: Lightly Salted Hoops, Salt and Black Pepper Tortillas, Roast Chicken Crinkle Crisps and Ready Salted Crinkle Crisps, (the "Products"). 4. Each Ticket will state on its face which one of the prizes (as listed below) the winner has won, and in addition will include a unique reference number which will be needed in order to claim that prize. The prizes available are as follows: (i) **3 x Disneyland Paris holidays for 2 adults and 2 children sharing a family room.** This prize is for 2 adults, who must be aged 18 or over and 2 children, who must be under the age of 12, sharing a family room, at the 3\* Disneyland Sequoia Lodge Hotel within the Disneyland Park Resort, including bed and continental breakfast. In addition this prize includes 5 days entry into the Disneyland Park Resort, €500 spending money and travel on Eurostar from St. Pancras, London (travel to St. Pancras and travel around Paris during the holiday are not included). The holiday must be taken before 15 September 2011 and may not be taken over Christmas, New Year, UK half term and Easter breaks and is subject to availability. Tour operator and other third party terms will apply to this prize. The winners of this prize as well as the people they choose to take on holiday must hold valid passports at the time of travel. Travel insurance not included and must be taken out by the winners. The Promoter will book the holiday as agent for the winner. (ii) **10 x 5<sup>th</sup> Generation 8GB iPod Nano's** (colours to be selected by the Promoter). 5. When a participant purchases a Product and finds a Ticket, he or she should send that Ticket, along with their name, address, telephone number and date of birth to Poundland Limited, Wellmans Road, Willenhall, West Midlands WV13 2QT and clearly mark on the envelope "Golden Ticket Competition". The Promoter will then, in the case of the holiday prize, liaise with the winner using the contact details provided in order to confirm details and make arrangements for booking the prize, including preferred dates. In the case of the iPod Nano prize, the Promoter will, at its cost, deliver the prize to any address in the United Kingdom, the time and date to be arranged with the winner. In both cases, the Promoter will bear the reasonable cost of such delivery. 6. To enter without purchase in Northern Ireland only, send your name, address and telephone number to the Promoter at Poundland Limited, Wellmans Road, Willenhall, West Midlands WV13 2QT and clearly mark the envelope "Golden Ticket Competition". The Promoter will then randomly select one of the Products to open. If a Ticket is found the Promoter will notify the winner using the contact details provided and will thereby liaise with the winner as to the arrangement for booking (including requested dates) and/or delivery of the prize. You shall not be contacted directly if you have not won. A list of winners shall be published on the Poundland website at [www.poundland.co.uk](http://www.poundland.co.uk) for a period of 4 weeks after the Closing Date. Only one entry per stamped mailed envelope. Bulk entries or entries sent through trade, consumer groups, agents or third parties will not be accepted. 7. Any late, damaged or incomplete winning claims will be automatically disqualified. The Promoter shall not be responsible for winning claims/Tickets that are lost, damaged or delayed for any reason whatsoever. 8. Winning claims must be made by 15 September 2010 ("Closing Date"). Failure to do so will disqualify the winning claim. 9. The Promoter reserves the right to amend, extend or terminate the Competition and the Closing Date if it deems appropriate and without notice. 10. Prizes are non-transferable will not be substituted (unless agreed in writing by the Promoter) and there is no cash alternative. The Promoter reserves the right to substitute prizes for those of equal or greater value at any time. 11. All entrants must be aged 18 or over, residents of the United Kingdom and must not be employees or family members of the Promoter, or any company or person involved in or associated with the Competition. 12. Winning claims are subject to a full verification process and the Promoter reserves the right not to award a prize if the Promoter is aware of or has reasonable grounds to believe that a winner is not eligible. In addition, the Promoter reserves the right to disqualify any winner if it has grounds to believe the entrant has breached any of these conditions. The Promoter reserves the right to refuse fulfilment of the prize if there is a suspicion of fraud or if the Promoter has reason to believe the winner has acted improperly. 13. The winners of the Competition may be required to participate in publicity and/or promotional activity at no

Under no circumstances shall the Promoter be liable for direct, indirect or incidental losses or damages, except for those damages or losses which are foreseeable, resulting from the Competition; however nothing shall exclude the Promoter's liability for death or personal injury as a result of its negligence. 15. By entering the Competition, the entrant hereby warrants that all information submitted by them is true, current and complete and that they are the appropriate age to enter the Competition. The Promoter reserves the right to request proof as to the eligibility of entrants. 16. These terms and conditions will be governed by the laws of England and Wales and any dispute will be subject to the exclusive jurisdiction of the English courts.
